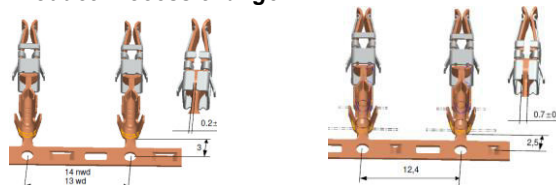

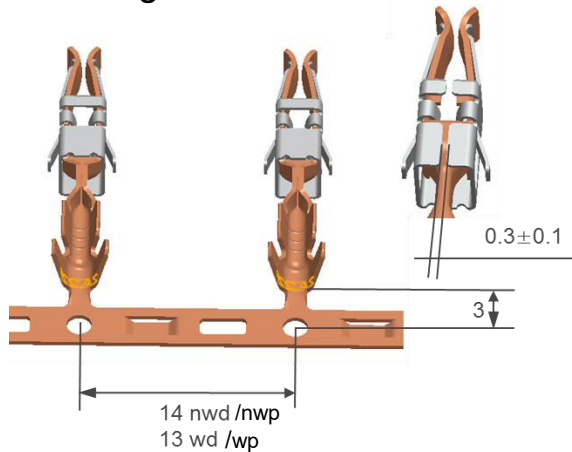

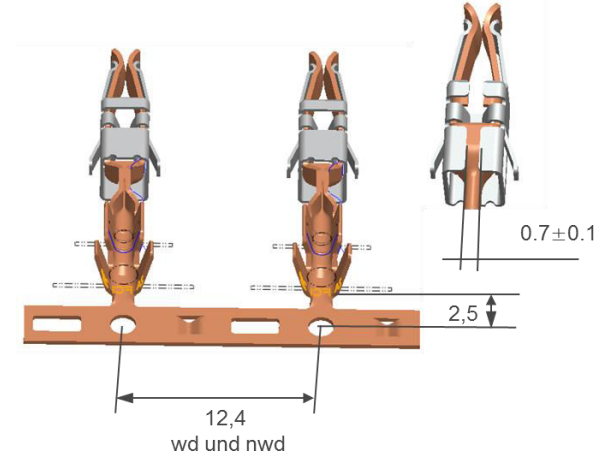
2-OUT DIE

Female contact DCS-2 2.8mm

- **Comparison stamp tool 1-out die versus 2-out die**
 - **Differences between both designs**
 - Gap on hood (Modification gap on the hood was necessary for the assembly on the contact body)
 - Distance pilot hole to the end of insulation crimp was reduced
 - Progression was reduced



stamp tool 1-out die

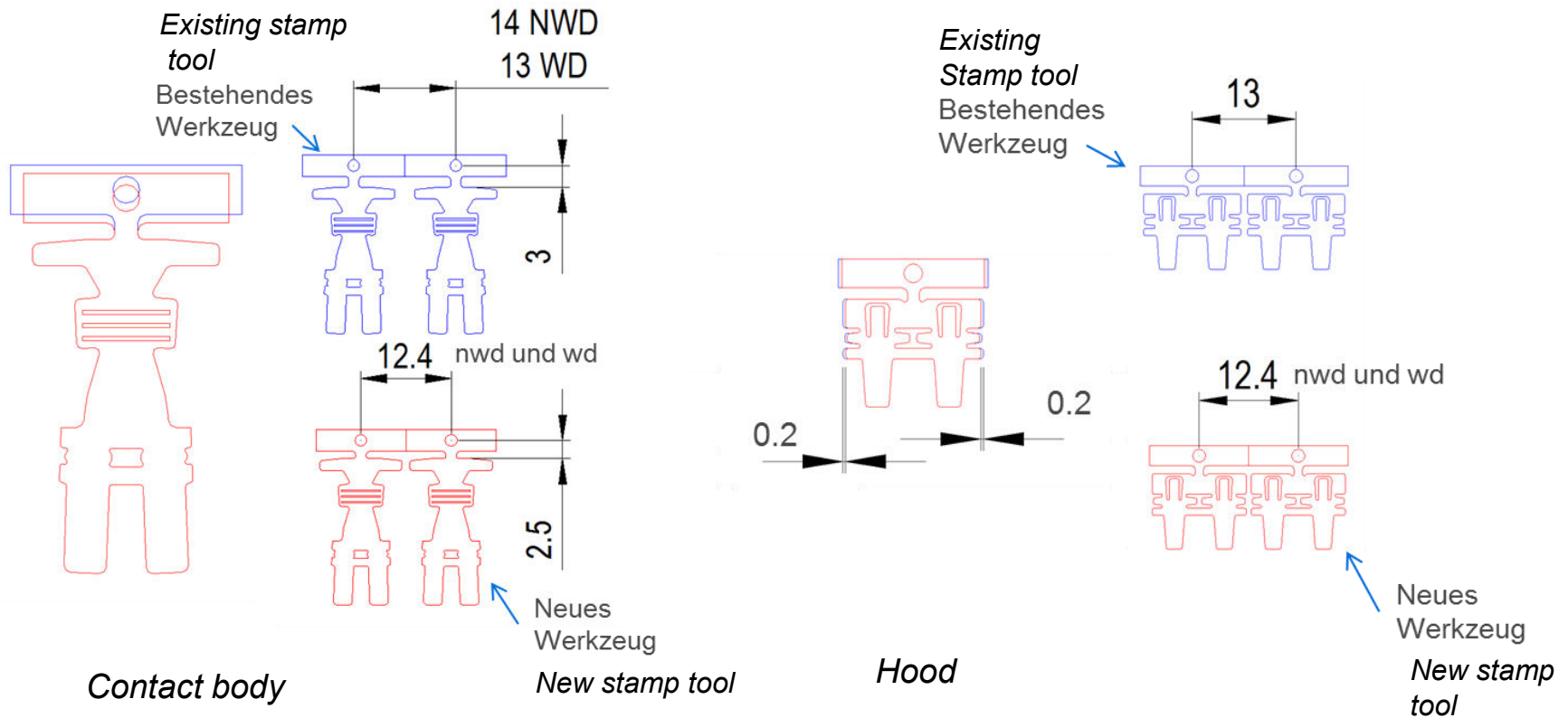


stamp tool 2-out die

◆ Comparison stamp tool 1-out die to 2-out

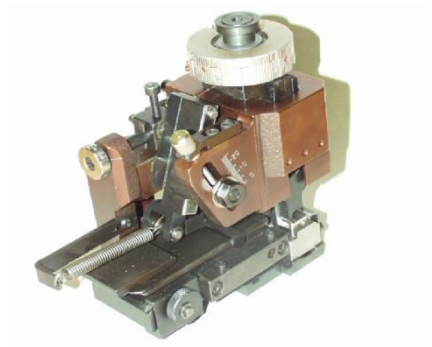
■ Layout contact body/ hood



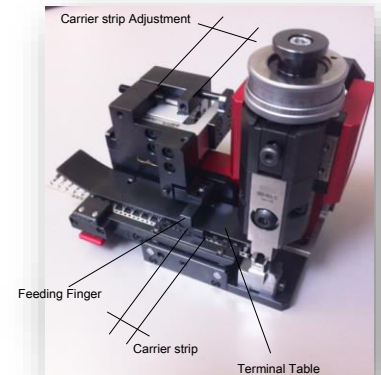

◆ Crimp Applicator

- New crimp applicator numbers: 6 520 04 09 / 39 / 47 / 48
- Spare parts identically
- The existing crimp applicators are adjustable according to new part dimensions
 - Progression change
 - Distance pilot hole to end of insulation crimp
 - 1 hour/ tool
- New crimp applicators
 - No adjustment necessary

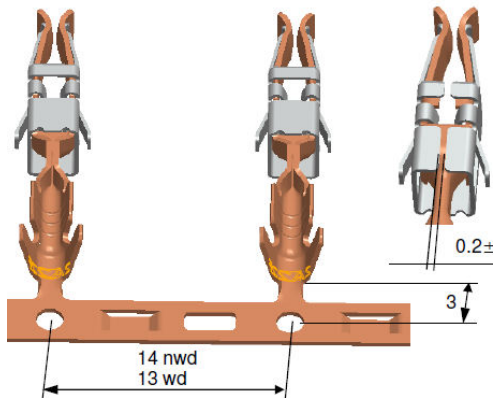


Mechanical feeding
Crimp Tool

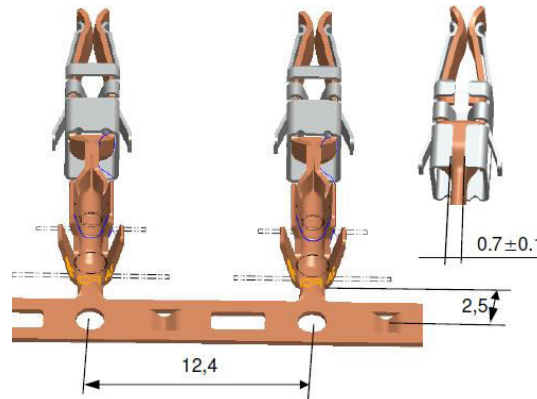


Pneumatic feeding

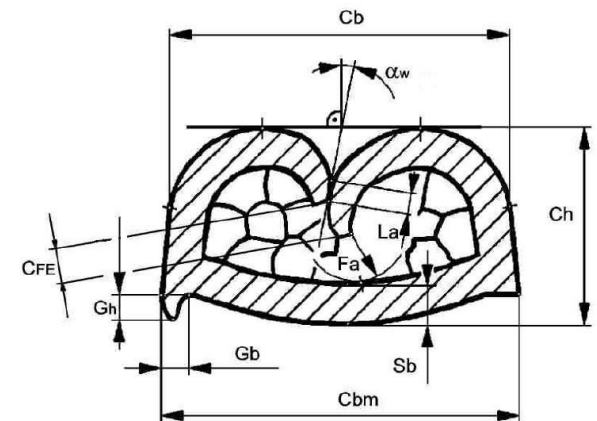
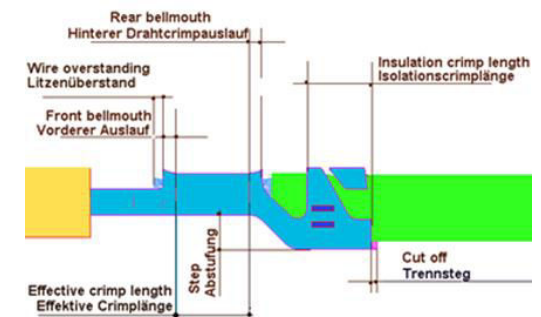


DCS-2 2,8 (old)
