

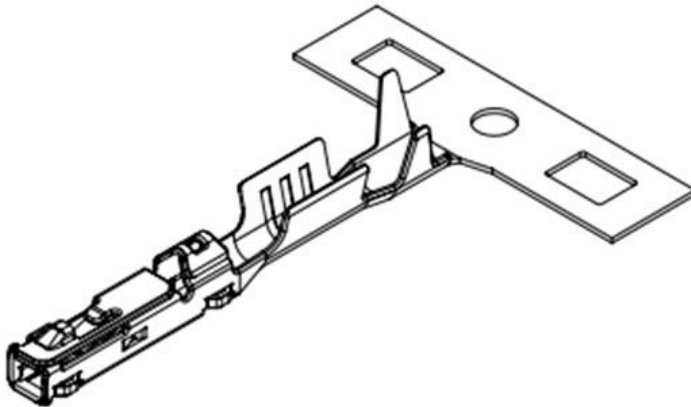

Overview

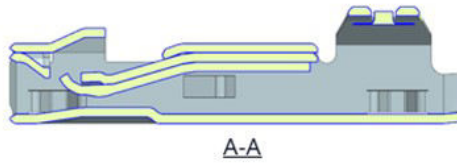

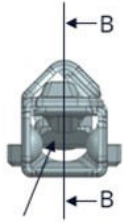
Terminal Design Optimization Detail

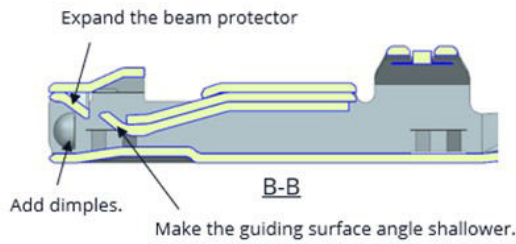


■ CTX-J(J-Japan) 50 TML
