Purpose/objective of the change

The purpose of this change is to support increasing digitalization requirements by enabling seamless, device-specific access to reliable product data by implementing the DT4I.

Detailed description of the change

As part of continuous product improvement, the QUINT4 PS/1AC/24DC/20/+ power supply is updated from Revision 05 to Revision 06. This revision introduces a digital enhancement by enabling access to the Digital Twin for Industry (DT4I according to IEC 61406) via an individual QR code on the device label. The Digital Twin provides centralized, instance-specific access to relevant product information such as documentation, approvals, and identification data throughout the product lifecycle, thereby improving digital transparency. The change is limited to digital information only and has no impact on the electrical, mechanical, or functional characteristics of the device.
