Purpose/objective of the change

The change is to update product marking, documentation, and published certificates due to modifications in the approval status for hazardous locations.

Detailed description of the change

The approval status of the PLC - INTERFACE product portfolio for use in potentially explosive atmospheres has been revised (see list). As part of the update, the EAC approval will be removed, and the UKCA logo will no longer be printed on the products. In addition, a new certification according to the Brazilian InMetro standard has been obtained.

Due to the update of the UL HazLoc approval, a new standard now applies. UL 60947, instead of the previous UL 61010.

The product marking will also be updated accordingly.

The previous marking text:

"Industrial Control Equipment

ALSO LISTED Process Control Equipment for Hazardous Locations

E140324 E199827"

will change to:

"Industrial Control Equipment

ALSO LISTED Industrial Control Equipment for Hazardous Locations

E140324 E360692".

This results in a change of the certificate number (E File). These changes require updates to the product marking, the printed information in the packaging leaflet, and the certificates provided in the e shop. A comparison of the new and current product marking is provided in the attachment.

Additionally, the items will also be updated with the QR Code. The new QR code links directly to the product's Digital Twin, providing centralized and easy access to all relevant documentation, technical data, certificates, and declarations of conformity.

No technical or functional product features are affected by this change.

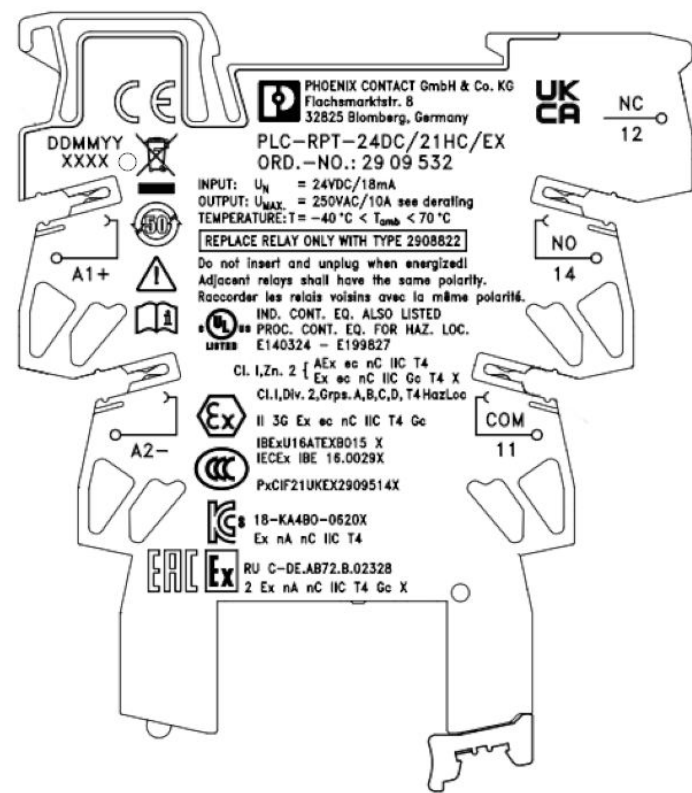

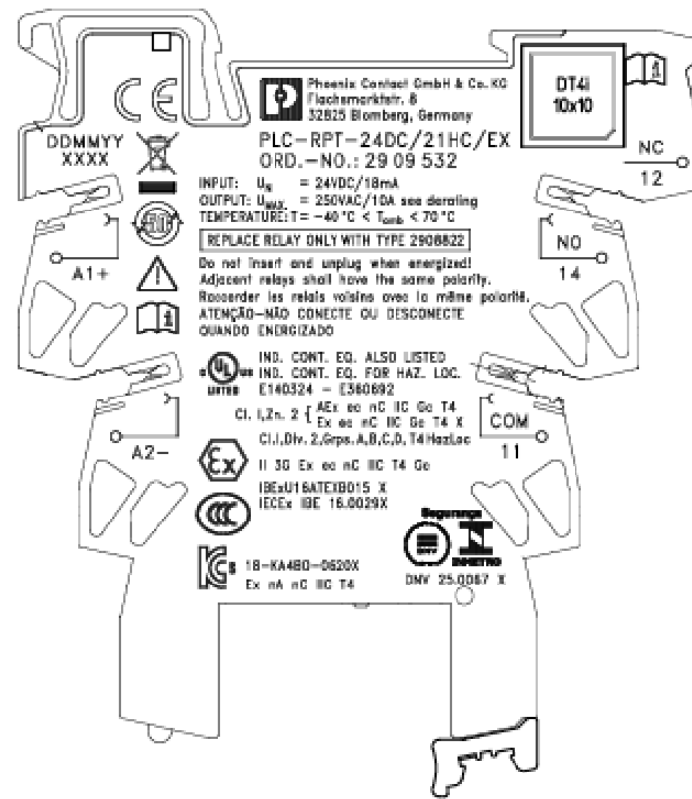
